

## 2024 Riverwood Ranch Boarding Agreement

### FEES

In consideration of board payments per month, paid by the Owner in **advance to the first day of each month**, the stable agrees to board the herein described horse(s) on a month to month basis commencing on \_\_\_\_\_. **One month's board payment must be paid in advance as a "security payment"** to the sum of \_\_\_\_\_. If the Owner fails to give the STABLE **thirty days' notice of their intent to terminate this Agreement**, the owner will forgo their security deposit to the STABLE.

The owner should pay fees for a partial month calculated on a pro-rated basis, based on the number of days the horse is actually boarded divided by 30 (the number of days in a standard month).

Late fees

- \$25 for 1-week late payment
- \$50 for 2-week late payment
- \$100 for 3-week late payment

### **Feed, Facilities and Care**

STABLE agrees to provide the following: in addition to normal and reasonable care and handling to maintain the health and well-being of the horse(s). Hay, feed, water, shelter and grade salt will be fed to the horses by the STABLE. Extra mineral/grain/supplements are the responsibility of the OWNER. If the owner packages/organizes/delivers these feeds the STABLE will provide the horse the feed, \$5 per Subsequent feedings.

### **Vaccinations**

All borders must comply/sign the mandatory Riverwood Ranch Biosecurity/Vaccination Protocol. Please see/sign attached documentation. Vaccinations are the responsibility of the owner.

**Written proof of vaccinations are required, before arrival of the horse to the ranch.**

**Subsequent proof of vaccination is required yearly. Deworming must be conducted every six months minimum.** Farrier, Vet services, deworming scheduling and administration will be the responsibility of the owner. STABLE Administration of dewormer/Farrier will follow above price chart. STABLE will not conduct vaccination administration.

### **Risk of Loss**

During the time that the horse(s) is/are in the custody of the STABLE, STABLE shall not be liable for any sickness, disease, theft, death or injury which may be suffered by the horse/owner. This includes but is not limited to any personal injury or disability the horse may receive while on STABLE premise. Owner fully understands and hereby acknowledges that STABLE does not carry any insurance for the use of the OWNER or the OWNER's horse including but not limited to, such insurance for boarding or any other purposes, for which the horse(s) is are covered under any public liability, accidental injury, theft, or equine mortality insurance, and that all risks relating to boarding of horse(s) or for any other reason, for which the horse(s) is/are the possession of STABLE, are to be borne by owner.

### **HOLD HARMLESS**

OWNER agrees to hold STABLE harmless from any claim resulting from damage or injury incurred while on STABLE's premises. OWNER or his guest and invitees, to anyone, including but not limited to legal fees and or expenses incurred by STABLE in defense of such claims. OWNER will sign and agree to the following explanations as listed on the following documentation

- Acknowledgement of Risk and Release of Liability
- Safety Equipment Acknowledgement and Release form
- Equine Acknowledgement of Risk and Release of Liability
- Riverwood Ranch Biosecurity and Vaccination Protocol

### **Emergency Care**

STABLE agrees to attempt to contact OWNER should STABLE feel that medical treatment is needed for said horse(s). In the event the STABLE is unable to contact OWNER within a reasonable time, (time shall be judged and determined solely by STABLE), the STABLE is then hereby authorized to secure any emergency veterinary care and or farrier care determined required for the health and well-being of said horse(s). The STABLE will have first choice of which service provider is used. All cost of such care secured shall be paid by OWNER within fifteen (15) days from the day the service occurs. This includes travel. OWNER and STABLE have agreed upon a monetary value of \_\_\_\_\_ to be the maximum amount spent on

medical bills without further consent of the owner, if under extreme circumstances the STABLE cannot reach the owner during an emergency situation before euthanasia options are considered.

### **Stable Rules**

Owner agrees he/she and his/her guests and invitees will be bound and abide by the Riverwood Ranch Rules Sheet (as per attached) and accepts responsibility for the conduct of his /her self and guests and invitees accordingly to these rules. Owner acknowledges the Rules include but are not limited to: (See full rules sheet attached)

- Signed copies of yearly waivers forms are MANDATORY for any person participating or entering equine activities or areas at Riverwood Ranch. IT IS YOUR RESPONSIBILITY FOR ALL OF YOUR GUESTS TO HAVE PAPERWORK SIGNED.
- No horses owned by the STABLE will be removed from the property without approval in writing. No horses owned by the STABLE will be used by the OWNER without approval in writing
- No equipment owned by the STABLE will be removed from the property without approval in writing
- No horses owned by the OWNER will be removed from the stable without written notification and confirmation to STABLE
- Paddocks will remain closed at all times and damaged fences and equipment will be brought to the attention of the STABLE as soon as possible
- Clean up after yourself and animals
- Toxic Conflict/Drama will not be permitted. Golden Rule is to create a safe/welcoming Ranch community. Three written warnings will be given before client will be terminated.

### **Default/ Termination of Agreement**

Barn may terminate this agreement immediately in the following situations:

- If the Owner fails to satisfy or comply with any terms of this agreement, or
- If the Owner fails to pay Fees by the due date specified in this agreement

STABLE acceptance of any late payment of fees shall not constitute a waiver of subsequent due dates or determinations of an event of default for late payment of fees. Any payment due to STABLE under this agreement shall be due and payable immediately upon termination of this agreement. STABLE shall have the right to recover legal fees and expenses on a solicitor and client full indemnity basis, if any, that STABLE incurs as a result of an event of default. This Agreement may not be assigned by Owner without the written consent of the Stables.

### **Notice of Termination**

**Either party may terminate this agreement for any reason on a thirty-day notice to the other party. If Owner fails to give STABLE thirty day's notice of his intent to terminate this Agreement, the owner will be required to pay additional Fees in the amount equal to one Month's rent to STABLE. Regardless of which party terminated the Agreement, Owner shall not remove the Horse from STABLE until all Fees owing to Barn have been paid in full.** STABLE will provide three written notices of ill compliance/offences to this agreement before termination.

**Right of Lien**

Owner is put on notice that STABLE has and may assert and exercise the right of lien, as provided for by the laws of the Province of Alberta, for any Fees and also for any storage or other charges due under this agreement. Owner further agrees STABLE shall have the right to enforce said lien according to the laws of the Province of Alberta and the Animals Keeps Act.

**Other Things OWNER Should Know**

- STABLE has the right to rotate horses between pens/ rotate pastures at any time when they see fit.
- Aggressive horses will be dealt with on a case by case basis to find solutions
- Blanket repairs are the responsibility of the owner. All Blankets must be upkept to a substantial condition before turnout to ensure safety of the horse
- If an animal is to die on the property, carcass disposal is the owner's responsibility. Arrangements can be made with the STABLE for a fee. A mandatory Autopsy may be required to ensure that the Riverwood Ranch Biosecurity Policy stays intact, at the expense of the owner. The decision of whether or not an autopsy is required lies solely with management at Riverwood Ranch. Client agrees upon signing contract of this potential fee.
- All horses will be subject to a one-week quarantine period when arriving to board. Horses may be subject to additional Quarantine periods throughout their stay based on their health and additional ranch factors. The decisions surrounding quarantine periods lie solely with the STABLE staff.
- Client agrees to ensure necessary maintenance/fees to maintain their horse's condition and pass mandatory monthly health checks as determined by Riverwood Ranch to continue boarding. Recommendations will be made by staff as to what's appropriate. (Farrier, deworming, body weight index)
