EQUINE LIABILITY

Owner acknowledges that the trainer cannot guarantee improvements in horse(s) standard. Trainer will update owner on progress and standard at end of training period at the minimum. Owner agrees to indemnify and save and hold Trainer harmless from and against any loss, liability, damage or cost arising from damage or injury caused by owner's horse(s) to anyone. Trainer agrees to attempt to contact Owner should Trainer feel that medical treatment or farrier service is needed for the horse(s), but if Trainer is unable to contact Owner, Trainer is then authorized (but is under no duty) to secure emergency veterinary or farrier care as Trainer, in Trainer's discretions, deems necessary for the health and wellbeing of the horse(s). All cost of such care secured shall be paid by Owner within fifteen (15) days from the day the service occurs. This includes travel. Owner and Trainer have agreed upon a monetary value of ______ to be the maximum amount spent on medical bills without further consent of the owner, if under extreme circumstances the Trainer cannot reach the owner during an emergency situation.

- Owner agrees to allow horse(s) to be trailered off of the Ranch premise for training purposes.
- Non-Emergent Medical Care and transport of the horse to and from the premise is the responsibility of the owner. Transport arranged by Riverwood Ranch can be provided at \$1.50 per km plus a \$40/hr wait time charge after the first hour of service
- Owner agrees that video and photos of the horse(s) will be recorded and sent and may be used for marketing purposes without additional consent of the owner for the ranch.
- A two-week assessment period will be conducted upon arrival for both the safety of the horse(s) and trainer. Trainer has the right to refuse training if the horse is deemed unsafe/unwarranted during this assessment
- If medical care is required, owner agrees to provide written documentation of the service to Riverwood Ranch (medical reports, dental reports, chiro assessment reports)

RISK OF LOSS AND STANDARD OF CARE

During the time that the horse(s) is/are in the custody of the Trainer, Trainer shall not be liable for any sickness, disease, estray, theft or death or injury which may be suffered by the horse(s) or any other cause of action, whatsoever, arising out of or being connected in anyway with the boarding of the horse(s) including negligence on the part of the Trainer, its agents and or employees. This includes, but is not limited to, any personal injury or disability the horse, Owner or Owner's guest may receive on Trainers premises. Owner assures that the horse has been cleared of any disease or injury by a vet before entering Trainers premises. Horse(s) is up to date on all mandatory vaccines mandated by Riverwood Ranch and is under compliance to the Riverwood Ranch Biosecurity/Vaccination protocols. A mandatory vet check clearance may be required at cost to the owner, if deemed necessary by Trainer to conduct training safely.

- A mandatory dental float will be conducted a maximum of 6months-1year (depending on age of the horse) before the horse will be trained at Riverwood. Dental records are mandated on file as well as records of compliance to Riverwood Ranch's biosecurity and vaccination protocol. If dental, vaccination, farrier or general health concerns are brought to the attention of the trainer, it is agreed that these concerns are to be rectified before training will resume at the expense of the owner. Care and custody charges will replace training costs until the issues are rectified. This decision lies solely with the Trainer. WOLF TEETH MUST BE PULLED. A dental report from a Dentist who chooses not to use anesthesia Will NOT BE ACCEPTED. A report conducted under anesthesia is Mandatory.
- Upon weekly health checks, it is understood that general horse health, body weight index, lameness, neurological or functional disability will influence the trainer's decision and ability to keep the horse(s) in training if adequate standards are not met. This decision lies equally with the owner AND trainer. The trainer does have the right to pull the horse from training if deemed unsafe/unwell to perform training in opposition to the owner's opinion.

TRAINING AGREEMENT

Training is based upon an \$1200 (+GST) wage per month agreement on a schedule of work of five days a week training minimum. A Feeding Surcharge may be added and are subject to change at Trainers discretion due to hay prices. A month is considered a period of 30 days from the date of arrival. If the horse is pulled from training for a short duration (Examples: Rest from injury, mandated rest period after dental float, extreme weather ect.) the client will be charged

based on the Care and Custody charge per day instead of the daily training rate. The remaining training days will be charged as per the daily training rate.

- Care and Custody Charge
 \$325 group paddock board per month/30 days= \$10.83 per day (+gst).
- Daily Training Rate
 \$1200 per month /30 days= \$40.00 per day (+gst).

Training rates include training and group paddock board with access to free choice hay, free choice salt, and shelter. Additional feed (mineral/grain/supplements) are the responsibility and cost/delivery of the owner. If the owner packages/organizes/delivers these feeds the trainer will provide the horse the feed, free of charge on WORK days Free. Subsequent feedings will be charged \$5/day. Specific requests for private/semi private paddock arrangements are also at additional cost to the owner and only an option if available. If space is available at the ranch, clients will be charged an additional \$150 fee per horse per 30-day period to be separated in a private/semiprivate pen. Private pens/other specific board arrangements will change the base price for the Care and Custody Charge.
